The invollved scientific disciplines are those of the followiing sectors: theoretical-politological (social and political philosophy, political theory, social science philosophy, law philosophy, geopolitics, history and theory of political doctrines, theory of institutions), sociological, communication of art, media and visual communication, media education, philosophy of language and communication, cross-cultural communication, cross-cultural studies.

The research projects may have a disciplinary, multi or cross-disciplinary characters, but they'll have always to show a direct care about the development of theorical paradigms and of application models according to a cross-cultural point of view, taking into an explicit account both diversities and dfifference (ethinc-culturals, sexuals, of gender, of skills) of the modern, complex ad multicultural societies (and of their intersections), besides their implications and involvements in order to national, transanational and global changes of the political institutions.
