PUBLIC SELECTION, FOR QUALIFICATIONS AND EXAMS, FOR THE RECRUITMENT OF NO. 1 UNIT OF TECHNOLOGIST OF SECOND LEVEL, PURSUANT TO ART. 24-BIS OF LAW NO. 240/2010, WITH A FULL-TIME, FIXED-TERM EMPLOYMENT CONTRACT OF 24 MONTHS AT THE DEPARTMENT OF BIOSCIENCES AND TERRITORY OF THE UNIVERSITY OF MOLISE (CODE 6/2022)

ART. 1

NUMBER OF PLACES AND PROFILE REQUIRED

A public selection, based on qualifications and exams, is hereby announced for the recruitment of no. 1 second level technologist, pursuant to art. 24-bis of Law no. 240/2010, with a full-time, fixed-term employment contract for a period of 24 months, extendable in accordance with the law, at the Department of Biosciences and Territory of the University of Molise for the needs of support to the project "Strengthening of the Italian Research Infrastructure for Metrology and Open Access Data in support to the AgriFood (METROFOOD-IT)" (cod. 6/2022).

Specifically, the professional figure required will have as his/her main task the management and supervision of the project as defined by the entire set of activities pertaining to the University of Molise, as well as the development of applications and services, ensuring periodic and constant monitoring of the development status and guaranteeing coordination with the other work units. It will also be dedicated to

- a. testing the applications developed, ensuring their robustness and reliability;
- b. defining analysis procedures based on Artificial Intelligence methodologies for blockchainmanaged data aimed at predicting trends in the sectors concerned.

The Administration reserves the right to suspend or terminate the contract if, even after the conclusion of the contract, the usability of the available funds should cease.

Upon expiry of the term indicated in the individual contract, the employment relationship may be extended within the terms of the law and in accordance with the regulations contained in the Collective Employment Agreements for the sector currently in force, in relation to the needs connected to the research activity as well as the availability of external economic resources.

ART. 2 GENERAL ADMISSION REQUIREMENTS

The following requirements must be met for admission to the selection procedure:

(a) Qualifications:



1) Degree in Computer Science, Computer Engineering, Information Science or equivalent obtained under the old system according to the modalities prior to the entry into force of Ministerial Decree 509/1999;

Master's Degree (LS) in Computer Science (23/S), Computer Engineering (35/S) or equivalent degrees obtained pursuant to Ministerial Decree 509/1999;

or

Master's degree (LM) in Computer Science (LM-18), Computer Engineering (LM-32), Computer Security (LM-66) or equivalent degrees obtained pursuant to Ministerial Decree 270/2004;

2) PhD in Computer Science or Computer Engineering;

In the case of qualifications obtained abroad, a declaration of equivalence is required pursuant to the regulations in force.

- a) Italian citizenship or citizenship of a European Union Member State;
- b) age not less than eighteen years
- c) registration in the electoral rolls of the municipality to which they belong or the reasons for their non-registration or cancellation from such rolls
- d) they must not have been convicted of criminal offences and must not be undergoing criminal proceedings;
- e) they must not have been dismissed or discharged from their previous employment with a Public Administration for persistent inadequate performance or declared disqualified for having obtained their employment through the production of false documents or documents with non-recoverable invalidity
- f) they must not be related or have a degree of kinship or marriage, up to and including the fourth degree, with the Rector, the Director General, a member of the Board of Directors of the Università degli Studi del Molise or with a professor belonging to the proposing Department in accordance with the provisions of art. 18, paragraph 1, letter c) of Law 240/2010
- g) (only for male candidates born before 31 December 1985) be in good standing with regard to military service;
- h) (only for citizens of one of the other European Union Member States):
- all the requirements for citizens of the Italian Republic, with the exception of Italian citizenship;
 - enjoy civil and political rights in the state of nationality or origin
 - have an adequate knowledge of the Italian language.

All the requirements must be met on the date of expiry of the deadline for submitting the application to take part in the selection. The absence of even one of these requirements will result in exclusion from the selection or, in any case, from access to the job.

Candidates are admitted to the selection subject to verification of the requirements declared in the application. Exclusion from the selection process due to failure to meet the admission requirements may be ordered at any time, even after the examinations have taken place, by reasoned decision of the Director General.

The Università degli Studi del Molise guarantees equality and equal opportunities between men and women as regards access to employment and treatment at work in accordance with Legislative Decree no. 198 of 11 April 2006 "Code of equal opportunities between men and women, pursuant to article 6 of Law no. 246 of 28 November 2005".



ART. 3

SUBMISSION OF APPLICATIONS

Applications to participate in the selection process, drawn up on plain paper in accordance with the instructions provided in the application form attached to this notice (Attachment A), available on the website http://www.unimol.it - Bandi di Gara e Concorsi / Concorsi / Personale Tecnico-Amministrativo / Concorsi pubblici a tempo determinato, must be addressed to the Director General of the Università degli Studi del Molise – Settore Reclutamento Personale Tecnico-Amministrativo-Via de Sanctis s.n.c. - 86100 Campobasso and submitted, under penalty of exclusion, within the peremptory deadline of 30 days from the day after the publication of the notice in the Gazzetta Ufficiale della Repubblica Italiana - IV Serie Speciale - Concorsi ed esami. Should this deadline coincide with a public holiday, it will be postponed to the first working day.

Applications to take part in the competition must be received by the deadline indicated above in one of the following ways:

- registered letter with acknowledgement of receipt. In this case, the date stamp of the accepting post office shall not be taken as the date of arrival of the application at the University's Computer Protocol and Archives Office;
 - ✓ Certified Electronic Mail (CEM) (in Italian Posta Elettronica Certificata (PEC)) to amministrazione@cert.unimol.it from a certified e-mail address issued by a CEM provider. In this case, the date of forwarding of the PEC shall be deemed to be the date of sending. Applications sent from non-certified e-mail addresses will be excluded. The subject of the PEC message must be: "Application to participate in the Technologist Competition (code 6/2022): candidate's name and surname".

Applications sent electronically to the institutional PEC box of the Università degli Studi del Molise must be accompanied, in PDF format, by all the documentation required by this call for applications.

The Administration accepts no responsibility in the event that the addressee cannot be contacted or if communications are lost due to an inaccurate indication of the address on the part of the applicant or due to failure or delay in communicating a change in the address indicated in the application, nor for any postal or telegraphic errors or in any case attributable to third parties, fortuitous events or force majeure.

The Administration accepts no responsibility for the dispersion of communications due to inexact indication of the PEC on the part of the participant or the indication of an invalid PEC or the indication of a traditional e-mail instead of the PEC in the application. Any misdelivery caused by failure to include the aforementioned wording in the subject line of the certified e-mail message, or caused by exceeding the maximum size allowed by the certified e-mail service concessionaire, or by failure to comply with the provisions laid down by the certifying body for the acceptance and delivery of the e-mail shall be attributable exclusively to the candidate.

The application, duly signed, must be filled in with all the information requested in Article 4 of this notice. Pursuant to Article 39 of Presidential Decree No. 445/2000, the signature of the application is not subject to authentication.

The following documents must be enclosed with the application:

• receipt of the payment of Euro 10.00 as a non-refundable lump-sum contribution for the



expenses related to the organisation and execution of the selection. The payment must be made exclusively through the PagoPA Portal accessible from the home page of the institutional website www.unimol.it (at the bottom of the page) or directly from the link: https://unimol.pagoatenei.cineca.it/frontoffice/home .The candidate must select in the "Reason for payment" section the item relating to Competitions, examinations and selection tests and enter in the "Reason for payment" section: Competition technologist cod. 6/2022 and Name and surname of the candidate.

- photocopy of a valid identity document;
- curriculum vitae, dated and signed. The curriculum vitae is for information purposes only as only the qualifications produced in accordance with the procedures set out in Article 7 below will be assessed:
- any qualifications deemed useful for assessment purposes and held on the expiry date of the competition notice, to be produced in accordance with the procedures set out in Article 7 below.

Candidates shall be excluded from the competition procedure:

- whose application is received after the deadline or in the case of a non-existent application (e.g. PEC without application form)
- whose application is unsigned;
- who have submitted their application by means other than those indicated above;
- who do not meet the requirements or who have omitted declarations concerning the possession of the mandatory requirements for admission or who have produced false declarations, certifications and/or documentation.

In all the above cases, the Administration may, by order of the Director General, at any stage of the competition procedure, exclude the candidate.

ART. 4 DECLARATIONS TO BE MADE IN THE APPLICATION

In the application to take part in the selection procedure, the candidate must indicate

- (a) surname, first name and tax code
- b) place and date of birth, residence with full indication of the address, telephone number, e-mail address, PEC (if applicable)
- c) (if different from the address of residence) the precise address to which communications relating to the selection should be addressed, undertaking to promptly report any changes that may occur subsequently.

Pursuant to Presidential Decree No. 445/2000 and subsequent amendments and additions, the candidate must declare in the application form that he/she meets the requirements set out in Article 2 of the notice, using the application form attached to this notice (Annex A).

Citizens of European Union Member States must also declare that they meet the requirements set out in Article 3 of Prime Ministerial Decree no. 174/1994, as specified in Article 2 above.

Candidates with non-Italian citizenship are required to submit their application in Italian, in accordance with the above-mentioned procedures and within the deadline established in article 3 above.

Candidates with disabilities who, pursuant to art. 3 of Law no. 104/1992, apply for the benefits provided for by art. 20 of the same law, must specify in the form attached to this call for applications (Attachment B) the aid required in relation to their disability as well as the possible need for additional time to complete the tests, both to be documented by means of appropriate certification issued by the competent public health facility, pursuant to articles 4 and 20 of Law no. 104/1992. In the event



of failure to provide such declarations and/or appropriate certification, the above-mentioned candidates shall forfeit the benefits envisaged.

In the application to take part in the competition the candidate must also declare whether or not he/she belongs to one or more categories that give rise to a preference and/or precedence, in the event of equal merit, as per art. 5 of Presidential Decree no. 487/1994. Failure to declare the possession of any preferential and/or priority qualifications, held on the date of the deadline for submitting the application to take part in the competition, does not constitute grounds for exclusion from the competition but precludes the possibility of producing the aforementioned qualifications in the event of success in the oral test, in accordance with the provisions of art. 7 of this notice.

The candidate must also authorise the Università degli Studi del Molise to process his/her personal data for the purposes of the management of the competition and for the purposes of the right of access to the records of the competition procedure in accordance with the regulations in force.

The Administration reserves the right to carry out appropriate checks, including random checks, on the truthfulness of the substitutive declarations. Should the above-mentioned check reveal that the content of the declarations is not truthful, the declarant shall forfeit any benefits deriving from the measure issued on the basis of the untruthful declaration, without prejudice to the provisions of Article 76 of Presidential Decree No. 445/2000 on criminal liability.

The application to take part in the competition must also be accompanied by any qualifications deemed useful for the purposes of assessment, in accordance with the procedures laid down in Article 7 of this notice.

ART. 5 EXAMINING COMMISSION

The Selection Board for the competition will be appointed by order of the Director General and composed in accordance with the provisions contained in the "University Regulations for the recruitment of technologists on fixed-term contracts pursuant to Article 24-bis of Law no. 240/2010" issued by R.D. no. 882/2022 prot. no. 31077 of 28 July 2022.

ART. 6 EXAMINATION TESTS

The examination will consist of a written test and an oral test.

The written test will consist of a test or questions with multiple or synthetic answers or a paper concerning the subjects inherent to the activities to be performed by the professional figure of technologist, as indicated in art. 1 of this notice.

The oral test shall consist of an interview covering, in addition to the topics of the written test, the following subjects

- Statute of the University of Molise;
- National Collective Employment Agreement for the University Sector 2006-2009 and the C.C.N.L. (National Collective Labour Agreement) for personnel in the Education and Research Sector for the three-year period 2016-2018;
- national legislation on safety in the workplace.

The oral test will also consist of ascertaining knowledge and use of the most common computer applications and knowledge of the English language.



During the test the use of books, vocabularies, calculators, computer instruments or any electronic device, including mobile phones, tablets, smartwatches, is not permitted, under penalty of exclusion from the competition.

The written test will be held at the Università degli Studi del Molise, III Edificio Polifunzionale, Via de Sanctis, Campobasso on Wednesday 12 October 2022 at 11 a.m. Candidates must present themselves at 10:30 a.m. for identification operations.

Any changes to the day, time or place of the written tests will be announced on the website (http://www.unimol.it - Notices of Competition and Competitions / Competitions / Technical-Administrative Staff / Open Competitions) at least five days before the date set for each test.

Candidates who have obtained a mark of at least 21/30 in the written test will be admitted to the oral test.

The list of candidates admitted to the oral test will be announced on the website (www.unimol.it) by 14 October 2022.

The oral test will be held at the Università degli Studi del Molise, III Edificio Polifunzionale, Via de Sanctis, Campobasso on **Thursday 3 November 2022 at 10:00 a.m.** Candidates must present themselves at 9:30 a.m. for identification operations. Depending on the number of candidates, the oral test may continue on the day following the scheduled one.

The oral test is considered passed with a mark of at least 21/30.

At the end of the oral test, the Commission will draw up a list of the candidates examined with an indication of the mark obtained by each of them and will arrange for this list to be posted at the examination venue.

Any changes to the date, time or place of the oral test will be announced on the website (http://www.unimol.it - Announcements of Tenders and Competitions / Competitions / Technical-Administrative Staff / Fixed-term Public Competitions) at least five days before the scheduled date.

The above calendar of competition test dates constitutes notification for all legal purposes. It is the responsibility of each candidate to monitor the site and consult the notices page relating to this selection.

Therefore, candidates who have not been notified of their exclusion from the competition procedure are required to appear on the date and at the examination venue indicated with only one of the following valid identification documents

- (a) identity card, passport, driving licence, nautical licence, gun licence or personal identification card if the candidate is a government employee;
- (b) recent photograph affixed on legal paper, with the candidate's signature authenticated by the mayor or a notary public.

Failure to appear for the examination tests will result in exclusion from the competition procedure.



Absence of the candidate will be considered as withdrawal from the examination, whatever the cause.

ART. 7

TITLES

The qualifications must be possessed on the date of the deadline for submitting the application to take part in the selection and must be attached to the application in one of the following ways

- in the original
- in a certified copy
- in a copy declared to be a true copy of the original with a special declaration in lieu of affidavit (Annex D).

Possession of the qualifications may also be the subject of a self-certification made in accordance with Articles 46 and 47 of Presidential Decree no. 445/2000, using the form in Attachment C, from which it is possible to clearly and circumstantially deduce the training and professional experience gained.

In the self-certification, the candidate must specify, in an analytical and precise manner, every element useful for the purposes of assessing the qualifications and carrying out the necessary checks on the truthfulness of the self-certified data (e.g. duration of the employment relationship - dd/mm/yy of beginning and end of the relationship, employer, training organisation, duration of the training course, etc.). This declaration must be signed and sent with the application together with a photocopy of the declarant's identity document.

The Commission will not assess the qualifications if all the elements and data necessary for their evaluation are not indicated.

Please note that, as provided for by Article 15 of Law no. 183 of 12 November 2011, certifications issued by the public administration regarding states, personal qualities and facts, as of 1 January 2012, are valid and usable only in relations between private individuals. In relations with bodies of the Public Administration and public service providers, certificates and affidavits are always replaced by the declarations pursuant to Articles 46 and 47, or by declarations in lieu of certification and affidavits in lieu of affidavits (Annexes C and D).

Documents and documents drafted in a foreign language must be accompanied by an Italian translation certified as conforming to the original text by the competent diplomatic or consular authorities or by an official translator.

The above-mentioned qualifications may not be awarded a total score higher than 30.

The categories of assessable titles and the corresponding points are as follows:

- Certificates of qualification and/or specialization issued as a result of attendance at professional training courses, only with a final grade, provided they are relevant to the post advertised: maximum attributable score 5;
- Scientific qualifications and publications: maximum attributable score 10;
- Professional experience in public or private entities provided it is relevant to the profile sought: maximum attributable score **15**.

Only the qualifications submitted by the candidate in the manner provided for in this article are assessable. The evaluation of the titles shall be carried out after the written test and before proceeding to the evaluation of the related paper, taking into account the criteria for the attribution of scores within the individual categories of evaluable titles.

At the end of the selection procedure, sixty days after the publication of the merit list on the University's Bulletin Board, this Administration shall return the documents attached to the application to the candidates who have expressly requested them. The documents must be collected from the *Technical-Administrative Staff Recruitment Office* by the interested party or his delegate within thirty days from the expiration of the aforementioned deadline, after which the titles will no longer be returned.

ART. 8 RANKING FORMATION AND APPROVAL OF ACTS

At the end of the examination tests, a merit list will be drawn up according to the descending order of the total score obtained by each candidate, based on the sum of the marks obtained in the written test and the oral test. To this sum will be added the marks awarded to the qualifications.

For the formation of the merit list, the provisions in force regarding preference and precedence referred to in Article 5, paragraph 4, of Presidential Decree No. 487/ 1994 will be observed in the case of equal scores.

On the basis of equal merit and qualifications, preference shall be determined:

- 1) by the number of dependent children, regardless of whether the candidate is married or not;
- 2) by having served with distinction in the civil service.

Pursuant to art. 3, paragraph 7, of Law No. 127/1997, as amended by art. 2 of Law No. 191/1998, if two or more candidates obtain, at the conclusion of the assessment of qualifications and examination tests, the same score, the candidate younger in age is preferred.

Candidates who have passed the interview must send, on their own initiative, to the *Director General* of the *Università* degli Studi del Molise - Technical-Administrative Staff Recruitment Office - Via de Sanctis s.n.c. - 86100 Campobasso, within the peremptory deadline of fifteen days from the date of the oral test, the documents, in original or certified copy, certifying the possession of the titles of preference and/or precedence, referred to in Article 5 of Presidential Decree no. 487/1994, assessable on the basis of equal merit and equal titles, already indicated in the application for participation in the selection.

The certified copy may be substituted by a special declaration in lieu of affidavit, made pursuant to Article 19 of Presidential Decree No. 445/2000, as supplemented by Article 15 of Law No. 3/2003, attesting to the conformity to the original of the copy of the document in the candidate's possession or of the document issued or kept by a Public Administration.

This documentation must be received, within the above deadlines, in one of the ways indicated in Article 3 of this notice of competition.

The competition acts, together with the general merit list, in which the winner is indicated, with observance of the preferences/preferences, are approved, under the condition precedent of the verification of the requirements for admission to employment, by a measure of the Director General published in the Official University Bulletin Board online at http://www.unimol.it and on the website at http://www.unimol.it - Notices of Tenders and Competitions / Competitions / Technical-Administrative Staff/ Public competitions for fixed-term contracts.



Notice of such publication will be given by means of a notice in the Official Gazette of the Italian Republic. From the day following that of the aforementioned notice, the terms for any appeals will begin.

ART. 9

RECRUITMENT INTO SERVICE AND ECONOMIC TREATMENT

The candidate declared the winner will be invited to enter into the individual fixed-term employment contract, for a period of 24 months, on a 75% hourly basis, in accordance with the provisions of the Collective Employment Agreements of the sector currently in force, and specifically in accordance with the C.C.N. L of the University Sector 2006-2009 and the C.C.N.L. relating to the personnel of the Education and Research Sector for the three-year period 2016-2018, as well as the "University Regulations for the recruitment of technologists on fixed-term contracts pursuant to Article 24-bis of Law no. 240/2010" issued by R.D. no. 882/2022 prot. no. 31077 of July 28, 2022.

The holder of the contract is granted the economic treatment due to the personnel of category D, economic position D3, of the roles of technical-administrative personnel of the Universities.

The employment relationship is automatically terminated, without the right to notice, at the expiration of the term indicated in the individual contract, unless extended in relation to the needs related to the research activity as well as the availability of external economic resources.

Under no circumstances may the fixed-term employment relationship be transformed into a permanent one. Pursuant to current regulations, the Administration shall, within thirty days of employment, verify the statements made by the successful candidate in the application regarding requirements and qualifications. In case of false statements or untrue data, the contract shall not be entered into, or, for relationships already established, shall be immediately terminated. It also entails the immediate termination of the employment relationship if the candidate fails to take up employment within the stipulated time, unless proven and justified reasons for impediment.

ART. 10 INCOMPATIBILITY

The employment relationship cannot be cumulated with other subordinate and/or self-employed employment contracts with public or private bodies, nor with similar contracts with this University or with other universities or with private scientific facilities, nor with a PhD, research grant or other postgraduate training activity. The position of the technologist on a fixed-term contract is incompatible with the practice of commerce and industry; the position of the technologist on a fixed-term contract on a full-time basis is incompatible with the practice of freelance activities.

For all matters not expressly provided for in this Article, the provisions of Article 53 of Legislative Decree No. 165/2001 shall apply.

ART. 11 PERSON IN CHARGE OF THE PROCEEDINGS

Pursuant to Law No. 241/1990, the Person in charge of the competition proceedings under this notice is Mrs. Marialucia STORTO, Technical-Administrative Personnel and Career Management Sector.

ART. 12 PROCESSING OF PERSONAL DATA



The personal data transmitted by the candidates with the application for participation in the selection will be processed for the purposes of managing the selection procedure and the eventual recruitment process in accordance with Legislative Decree No. 196/2003, Code on the Protection of Personal Data, as well as the European Regulation on the Protection of Personal Data No. 2016/679 in force since May 25, 2018. The data controller is the Università degli Studi del Molise, in the person of the pro tempore legal representative, domiciled for the purpose in Campobasso, via F. de Sanctis.

ART. 13 RIGHT OF ACCESS

Applicants are guaranteed the right of access to documentation pertaining to the selection process, in accordance with relevant regulations.

ART. 14 FINAL RULES

For matters not expressly regulated by this notice and by the "University Regulations for the recruitment of technologists on fixed-term contracts pursuant to art. 24-bis of Law no. 240/2010", issued with R.D. no. 882/2022 prot. no. 31077 of July 28, 2022, the general rules on access to public employment as well as the general rules governing the conduct of competitions and other forms of recruitment in public employment and in particular the rules contained in the Collective Employment Agreements currently in force apply.

The Università degli Studi del Molise reserves the right, at its sole discretion, to revoke, modify or suspend this notice for reasons of a financial nature and/or for supervening reasons of expediency in the interest of the University and/or for supervening regulatory provisions or sectoral collective bargaining agreements.
