## Position:

Recruitment procedure for n. 1 fixed-term researcher post, pursuant to art. 24, paragraph 3, letter a) of Law 240/2010 for the competition sector 11/D1 PEDAGOGY AND HISTORY OF PEDAGOGY at the Department of Humanities, Social Sciences and Education (SUSeF), University of Molise.

## Program of teaching, student service, and research activities:

The candidate will carry out didactic tasks referring primarily to the sectors of General and Social Pedagogy (M-PED/01) and History of Pedagogy (M-PED/02) for degree courses of the Department of Humanities, Social Sciences and Education, and, subordinately, for other degree courses of the University of Molise, and will have to carry out tutoring activities for students.

The candidate, through specific skills in the methodology of pedagogical and educational history research, will also have to continue to carry out study and empirical analysis activities in sector 11/D1 Pedagogy and History of Pedagogy (Scientific Disciplinary Group Pedagogy and History of Pedagogy and Education), with particular reference to research activities linked to the themes of the reciprocal relationship between educational practices and, in addition to the methodology of pedagogical research, educational, school and university systems, teacher training and the corresponding methodological implications. The research activity, also international, will be carried out in the context of the various articulations of the most accredited and innovative historical-pedagogical research, with particular reference to the history of the school and of the historical-educational heritage in its material and immaterial dimensions and to the implications for learning processes. Finally, it will have to contribute to the Third Mission activities promoted by the Department of Humanities, Social Sciences and Education with particular reference to public engagement and the transfer of the results of scientific research in the field to civil society.

## Objectives of scientific productivity (publications, conferences, other types of products) and qualitative characteristics of scientific production:

The candidate must set high-profile research objectives, aiming at national and international publications (at least 3 scientific products in band A journals of sector 11/D1) that will lead him/her to make a significant contribution to the evaluation of the scientific production of the Department of Humanities, Social Sciences, and Education and of the University and Department Research Centres; he/she must also undertake to participate annually in national and international research conferences and seminars relating to the research areas of sector 11/D1.

Lastly, he/she must undertake to participate in calls for research projects of relevance, including international ones, and, where feasible, to organize scientific initiatives for the dissemination of the scientific research activities of the Department of Humanities, Social Sciences and Education on topics of interest to the field of social pedagogy and the history of educational processes.
